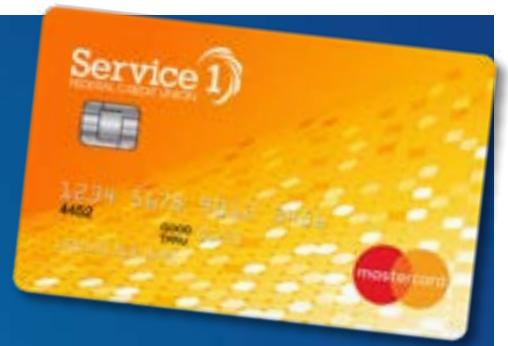

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The FIS ScoreCard® Rewards ScoreBIG Sweepstakes (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Tuesday, August 1, 2023 and ends at 11:59:59 PM ET on Tuesday, October 31, 2023 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who are age 18 or older at the time of entry that are the primary cardholder in good standing with one (1) of the participating financial institutions (the "Financial Institutions")*, enrolled in the ScoreCard® branded program as of July 31, 2023 and have a valid email address on file with their ScoreCard account** as of the time of the drawing (the "Entrant"). Entrant must remain in good standing through the Sweepstakes Period and at the time of winner notification and verification. Void in Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of Fidelity Information Services, LLC., (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator"), Financial Institutions, and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

HOW TO ENTER: There are three (3) ways to enter.

Method #1: Purchase Entry. During the Sweepstakes Period, for every qualifying purchase transaction using ScoreCard enabled debit or credit card connected to your eligible Financial Institution account will receive one (1) entry into the Sweepstakes (the "Purchase Entry"). **Purchase Entries must be received between Tuesday, August 1, 2023 at 12:00:01 AM ET and Tuesday, October 31, 2023 at 11:59:59 PM ET.** Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at <https://www.scorecardrewards.com/#/privacy>.

Method #2: ScoreCard Account Entry. Eligible participants will receive one (1) entry into the Sweepstakes if he/she has an eligible Financial Institution account in good standing at the time of statement production for the month of August, September, or October, respectively (each, a "ScoreCard Account Entry"), for a maximum of three (3) ScoreCard Account Entries. **ScoreCard Account Entries must be received between Tuesday, August 1, 2023 at 12:00:01 AM ET and Tuesday, October 31, 2023 at 11:59:59 PM ET.** Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at <https://www.scorecardrewards.com/#/privacy>.

Method #3: Alternate Method of Entry ("AMOE") / Mail-in Entry. To enter without making a ScoreCard purchase, mail a postcard (the "Mail-In Entry"), including your name, complete address, email address, name of Financial Institution participating in the Sweepstakes, and phone number to the following address to receive one (1) entry into the Sweepstakes: The **FIS ScoreCard® Rewards ScoreBIG Sweepstakes**, PO Box 728, Social Circle, GA 30025-0958. **Each Mail-In Entry must be mailed separately and must be postmarked between Tuesday, August 1, 2023 and Tuesday, October 31, 2023, and received by Tuesday, November 7, 2023.** Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsor and will not be returned or acknowledged. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned.

PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS. Odds of winning will depend upon the total number of eligible entries received.

Grand Prize: There are three (3) Grand Prizes available to be won. Grand Prize will be based on a transaction tier for transactions made during the Sweepstakes Period.

Tier 1: Potential winners who made 30 transactions or less during the Sweepstakes Period will receive (500,000) ScoreCard points (ARV \$5,000)

Tier 2: Potential winners who made 31 transactions to 59 transactions during the Sweepstakes Period will receive (1,000,000) ScoreCard points (ARV \$10,000)

Tier 3: Potential winners who made 60 or more transactions or entered via the AMOE method during the Sweepstakes Period will receive (1,500,000) ScoreCard points (ARV \$15,000)

The Maximum ARV of Grand Prize is: \$15,000.00.

The total Maximum ARV of all prizes available to be won: \$45,000.00.

RANDOM DRAWING: The winners will be selected in a random drawing on or about **Tuesday November 14, 2023** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION:

Potential Grand Prize winners will be notified via email and/or phone, and will be required to sign and return, within four (4) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the winners to furnish his/her Social Security Number for the sole purpose of tax reporting, as required by law. Winners will also be required to provide a government issued photo identification. Noncompliance will result in disqualification and an alternate winner may be selected.

The prize will be awarded within approximately 45 days after the winner is verified. ScoreCard points will be deposited in the winners account associated with the winning entry. If the cardholder belongs to a cash back program, a points account will be created for them and the login information emailed to them upon award.

If a winner is otherwise eligible under these Official Rules, but is nevertheless deemed a minor in his or her state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases on minor's behalf, as applicable.

If a prize notification or prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these rules that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing. Only two (2) alternate winners may be determined through this process, after which the prize may remain un-awarded.

Sponsor may ask any Entrant or potential winner to provide Sponsor with proof, to Sponsor's satisfaction, that such party is the primary account holder.

The Released Parties are not responsible for: (i) lost, late, misdirected, damaged or illegible entries; or (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or at any web site or any combination thereof; or (iii) any injury or damage to entrant's or any other person's computer related to or resulting from participating in the Sweepstakes. By participating in the Sweepstakes, you (A) agree to be bound by these official rules, including all eligibility requirements, and (B) agree to be bound by the decisions of Sponsor and the Sweepstakes Administrator, which are final and binding in all matters relating to the Sweepstakes. Sponsor reserves the right to: (y) permanently disqualify from any Sweepstakes it sponsors any person it believes has violated these official rules; and (z) withdraw a method of entry if it becomes technically corrupted (including if a computer virus or system malfunction inalterably impairs its ability to conduct the Sweepstakes). If for any reason this Sweepstakes is not capable of running as planned due to an infection by a computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and/or to cancel, terminate, modify or suspend the Sweepstakes. In such event, Sponsor reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment or to cancel any or all Promotions without awarding any prizes, as Sponsor determines in its sole discretion. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

GOVERNING LAW AND LIMITATION OF LIABILITY:

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Florida, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Pinellas County, Florida and any other

court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award are final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Pinellas County, Florida. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Pinellas County, Florida. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
